PRESIDENTS REPORT ANNUAL GENERAL MEETING 8th May 2025

It is with great pride that I present the President's Report for the 2025 AGM. The 2024–2025 season has been one of continued growth, success, and community engagement for Dubbo Touch Association (DTA). I would like to take this opportunity to highlight key achievements and express appreciation to those who contributed to another outstanding year.

Key Highlights

1. NSWTA Junior State Cup - Northern Conference

Dubbo successfully hosted its third consecutive Junior State Cup Northern Conference, in partnership with Dubbo Regional Council. This year's carnival welcomed 207 teams, maintaining its status as the largest sporting event in Dubbo. The atmosphere both on and off the field was electric, with the economic and social benefits evident across the region.

A special mention goes to our local teams for their outstanding performances, particularly the 10s boys and girls, and the 12s girls, who all placed in the top 4 in their divisions. All teams continue to improve which is a testament to our club's progress.

We sincerely thank the sub-committee and the many volunteers who dedicated their time to the success of the event.

2. Club Participation

- Junior Competition: Growth from 91 to 109 teams, with over 1,000 junior players from U7s to U15s.
- Senior Competitions:
 - Summer: 55 Mixed, 23 Men's, and 8 Women's Safari Series
 - Winter: 14 Men's and 30 Mixed teams.
 These consistent numbers reflect the stability and popularity of our competitions.

A survey of our members saw high overall satisfaction rating with the junior and senior mixed, men's and women's competitions.

3. Referee Development

We have continued to grow our referee base, with upgrades achieved at representative carnivals and local level courses increasing our Level 1 referees particularly junior referees. Thank you to senior referees who consistently support our junior and senior competitions.

Upcoming Changes

Touch Football Australia introduced a national "One Fee Model" two years ago. From July 2025, NSW Touch will align with this model, introducing a \$30 registration fee (in addition to TFA's \$22), resulting in a \$52 annual fee per participant. Further details were circulated via email, and our committee will engage in discussions with NSWTA regarding this change.
